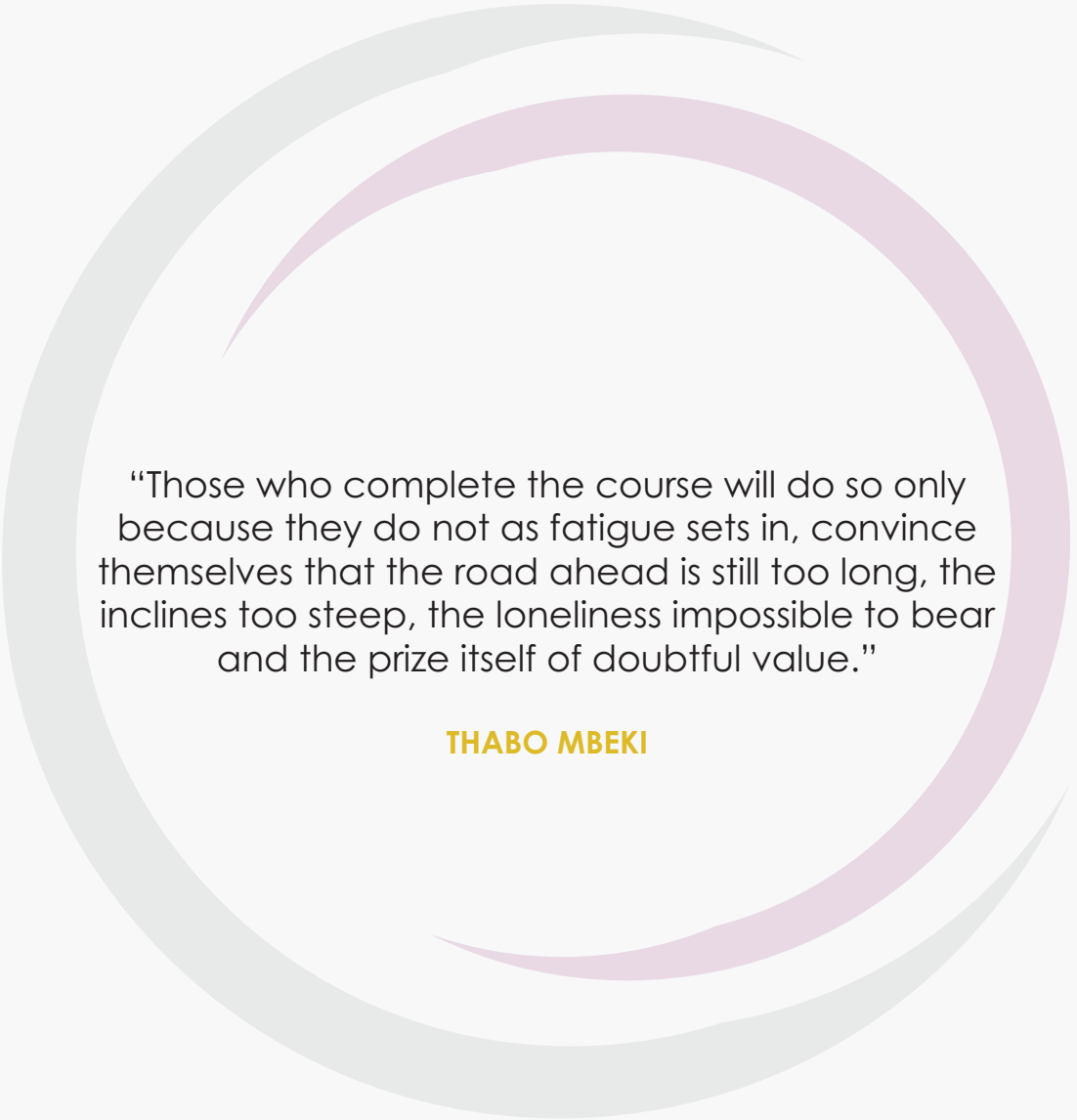

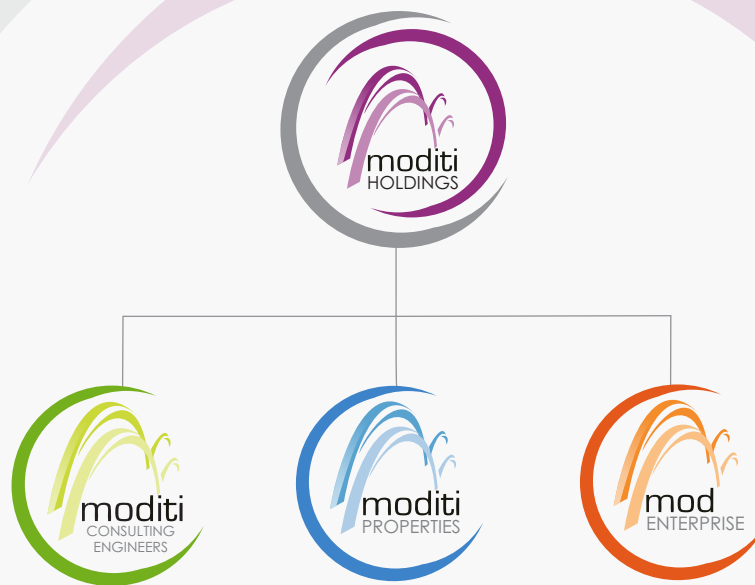
About Us
